IMPLEMENTATION OF DAY-NULM

NO. 1151. DR. T. SUMATHY (a) THAMIZHACHI THANGAPANDIAN:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the performance of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) being implemented in the country;
- (b) the reasons for not allocating any funds to the scheme in this year's budget despite allocating Rs. 450 crore in 2022-23 and having the revised estimates amounting to Rs. 275 crore for this scheme;
- (c) the number of SHGs formed under the scheme so far, State-wise; and
- (d) the number of the areas of focus in the functioning of SHGs formed under the scheme?

ANSWER

 (a): Ministry of Housing & Urban Affairs is implementing a Centrally Sponsored Scheme viz. the "Deendayal Antyodaya Yojana – National Urban Livelihoods Mission (DAY-NULM)" to reduce poverty and vulnerability of urban poor households on a sustainable basis. Since inception of the Mission, 14.51 lakh urban poor have been imparted skill training to enhance their employability, out of which 7.71 lakh have been placed under self and/or wage employment. Loans with the provision of interest subvention have been disbursed to 8.34 lakh beneficiaries for self-employment through individual or group micro-enterprises. 8.34 lakh Self-Help Groups (SHGs) have been formed, out of which 5.91 lakh SHGs have been assisted with Revolving fund and 7.64 lakh loans have been disbursed under SHG bank Linkage Programme for taking up activities for improving incomes. Street Vendor Survey has been completed in 3,467 cities in which 53.76 lakh street vendors have been identified. Out of which 30.99 lakh street vendors have been provided Identity Cards. Out of 2,544 Shelters sanctioned for Urban Homeless, 1,855 shelters are functional.

- (b): The funds available with the States in their SNA account are being utilized for implementation of the Mission.
- (c): The State/UT-wise number of SHGs formed under DAY-NULM from 01.04.2014 to 30.06.2023 is at Annexure-I.
- (d): The SHGs under DAY-NULM are formed under more than 40 activities/sectors including domestic workers, agriculture, food processing, handicrafts, apparels etc.
